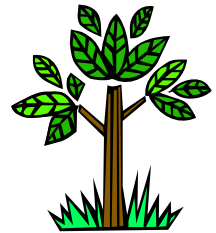

Eligibility requirements for diagnostic services include: under 21 years of age, have a handicapping or possibly handicapping condition, complete an application for services, and receive pre-authorization by MNCSHN except in medical emergencies.

Eligibility requirements for treatment services include: a medically eligible condition, completion of an annual application for services, meeting financial eligibility requirements as determined by review of family's financial resources; received pre-authorization by MNCSHN before treatment is provided.
