SWIF CELEBRATES REGION'S GREATEST GENERATION WITH \$25,000 GRANT TO HONOR FLIGHT SOUTHWEST MINNESOTA

We go to work. We get kids to and from school. We volunteer with local organizations. We gather with family and friends for the holidays. In the midst of our busy everyday lives, two days can seemingly pass with the blink of an eye, making it easy to miss opportunities to reflect, remember and celebrate. But two days is enough to create once-in-a-lifetime opportunities for southwest Minnesota veterans to do just that.

That's why SWIF made a \$25,000

grant to support Honor Flight Southwest Minnesota and kick-off our 25-year anniversary.

Honor Flight Southwest Minnesota, a chapter of the national, nonprofit organization Honor Flight Network dedicated to honoring America's WWII veterans with a two-day trip to Washington, D.C., took its second flight Oct. 1 and 2 from Sioux Falls. This trip included 108 veterans—mainly WWII—from throughout the region, giving

much-deserved recognition to those deemed the Greatest Generation.

"It was heartwarming," said Navy Veteran John (Bud) Qualley of Canby as he recalled the trip.

Qualley remembered the excitement and overwhelming show of gratitude received as veterans made their way

HELPING WHERE WE CAN

We realize that people in our region continue to face challenges that fall outside of SWIF's focus areas but that hasn't stopped us from helping where we can. Over the past 20 months, SWIF staff collected food and personal cash donations for 14 food shelves throughout our region, selecting each recipient based on what we knew was happening in specific counties – company layoffs, businesses closing, tragic accidents, fires – that would increase needs at the local food shelves.

This fall, Accounting Specialist Deb Berggren, Loan Specialist Janet Menton and Community Resource Assistant Marsha Frauendienst made a challenge to the SWIF staff and board of directors. To honor our 25th anniversary, they challenged us to collect at least 25 pounds of food, \$25 or 25 items for the counties in our region that we hadn't yet given to before the end of our anniversary year.

With additional support from our board, we made a great start to that challenge by collecting 107 pounds and \$424, which was delivered to Jackson and Rock counties in November. More boxes are being filled and will continue to be delivered throughout the region.

It usually takes students awhile to get back into the groove of a new school year. But participants of the Youth Energy Summit (YES!) program have jumped back into another exciting season.

The YES! program and partners were honored by receiving the 2010 Minnesota Environmental Initiative Award for Environmental Education last May and haven't slowed down since. Over the summer, a new website www.youthenergysummit.org was launched to provide more resources and the new site has been a great way for coordinators, coaches and teams to connect, share ideas and generate enthusiasm for the new season and their energy action projects.

With great success in its first three years, YES! was approached to expand further into Owatonna-based Southern Minnesota Initiative Foundation's service area as well. This partnership, along with continued partnerships with Prairiewoods Environmental Learning Center and Prairie Ecology Bus Center, added capacity and funding to support teams throughout all of southwest and southern Minnesota.

Thirteen teams kicked off the 2010-2011 season at the Fall Summit and Career Expo Sept. 28 at Southwest

Minnesota State University in Marshall. At the Summit, students learned about energy opportunities and issues and begin planning for their energy action projects. They also connected with businesses, organizations and other resources in the clean energy industry that will serve as great contacts throughout the season.

2010 YEAR

The past year marked a time of new and continued challenges but also one filled with amazing opportunities for southwest Minnesota. The recession created both an increased demand for SWIF's program services and pressure on private and public revenue streams. Collaboration across traditional programmatic lines and practical use of process improvement tools helped SWIF focus on the best use of our resources while leveraging those available to the region.

PROGRAM HIGHLIGHTS

- Awarded \$1.65 million in grants to meet regional and local needs
- Closed 45 loans totaling \$2,107,061 to support businesses
- Created or retained 176 jobs through the Revolving Loan Program and Microenterprise Loan Program
- Approved 13 REDI loans throughout the state encompassing an estimated 1,088 MW of community wind and estimated total development cost of \$2.5 billion
- Educated nearly 2,000 people about wind energy development at Rural Energy Development Initiative (REDI) forums
- Hosted second annual business leadership development event, Leading By Example II: Boomers to Rock Stars, attended by 250 regional leaders
- Provided 4,260 hours of technical assistance in partnership with the Small Business Development Center to 390 entrepreneurs
- Expanded YES! program to 20 teams, engaging more than 275 students, 175 businesses and organizations and impacting 42,000 community members
- Established new Early Childhood Initiative sustainability funds for the Willmar and Ortonville teams
- Launched the new Nonprofit Leader's Academy
- Administered a \$1 million land acquisition and planning grant from the Legislative Citizen Committee on Minnesota's Resources for the Minnesota River Valley Green Corridor Project
- I Helped all fund partners raise more money, acquire more donors and award more grants
- Received awards for the Entrepreneurship Initiative and YES!
- Appointed three new members to our Board of Directors, including Marcy Costello, Lakefield; Janice Nelson, Montevideo; and Robert Thurston, Olivia





WHAT WILL YOU GIVE?

SWIF was established in 1986 by The McKnight Foundation in response to the economic crisis of the 1980s. Greater Minnesota was struggling to survive and McKnight was one of the first to take notice and take action. They created six Minnesota Initiative Funds to deliver an economic counterpunch and become leaders of Minnesota's rural resurgence.

Since then, SWIF has received significant financial support from The McKnight Foundation. As of the beginning of Fiscal Year 2011 (July 1, 2010), we had raised just over \$1.5 million of the \$1.8 million goal – the amount that McKnight challenged us to raise from Fiscal Years 2006 through 2011.

With just six months left in our current challenge, we are striving to meet the match! We need to raise just over \$250,000 for the SWIF General Endowment by June 30, 2011, to meet our goal. We would love nothing more than to cap off our 25th anniversary year by achieving this ambitious goal and meeting the challenge—doing so will ensure that southwest Minnesota will be that much stronger for years to come!

There are several great opportunities we have within The McKnight Foundation's matching challenge grant:

SWIF Loan Assists Wind Energy Firm Expansion

Outland Renewable Energy, a Canby-based wind energy firm with additional offices in Mendota Heights and Guymon, Okla., recently received a loan through SWIF's Revolving Loan Fund to support a major business expansion. The firm is focused on developing, owning, operating and maintaining commercial renewable energy

projects in partnership with landowners, rural communities and municipalities. They have an unwavering commitment to leading-edge technology and investor-owners, as well as remaining environmentally responsible.

Outland's steady growth of business and competitive safety record has also garnered them the ISO 9001:2008 certification as commissioners, operators and maintenance of wind energy facilities throughout the U.S. and abroad. They now have more than 125 service technicians and nearly 1,000 megawatts under service agreements.

The Outland founders believe in improving rural communities through profitable investments in and management of renewable energy projects. The catalyst for the Canby expansion was re-purposing an old furniture store and tractor dealership to accommodate Outland's growing service division and create a secure warehouse area for high-value inventory.

"We're very thankful to have the support of SWIF," said Outland President and COO Steve Scott. "Without their resources, our expansion here in Canby would have been insurmountably more difficult. They provided the flexibility and speed we needed to clear several key hurdles hindering our growth in the local community."

TRAINING THE TRAINERS

Minnesota Children's Museum Brings Professional Development to Region

After the regional Early Childhood Initiative (ECI) team experienced a Minnesota Children's Museum workshop by trainer Nikki Polifka at a statewide meeting, they knew this was a professional development opportunity that must come to southwest Minnesota.

"We became determined to bring the workshops to the region so our educators who really needed access to professional development opportunities could attend and in turn, can help kids become more school ready," said SWIF Program Officer Sara Carlson. "Individual ECI coalitions couldn't afford to bring the workshops out on their own so it was a perfect opportunity to leverage our collective resources in the region."

Ortonville, Redwood Falls, Slayton/Murray County and Willmar ECI teams served as hosts, with the Flexible Learning Year (FLY) schools consortium offering an extra training at the Redwood Falls site. In addition, Ortonville, Slayton and Wabasso area ECIs paid for add-on evening sessions for child care and early care professionals who couldn't attend a daytime session. No fees were charged to participants.

Topics varied by community but included science, music and movement, literacy and math. They incorporated theory, best practices and discussion about why the subjects are critical to early development as well as time for participants to experience hands-on activities. Each participant received a packet with 10 to 20 lessons to bring into their own classrooms.

"When given an affordable, accessible option, teachers

who are responsible for our next generation of learners will engage in quality professional development," Carlson said. "This was a wonderful way to provide an opportunity in locations making it much easier on stretched program budgets and staff schedules across the region."

The response to these sessions has been so positive, SWIF and Minnesota Children's Museum are in conversation about a fall 2011 series in southwest Minnesota.

based on research evidence of what works and what does not.

This online tool covers a wide range of issues including aging, civic engagement, early childhood, economy and workforce, education, environment, health, housing, public safety and transportation. It's useful for city officials, educators, grant seekers, business owners—anyone interested in learning about and improving their community.

Led by Wilder Research, the initiative builds on the prior success of Twin Cities Compass, a similar project for the seven-county metro region. Nine foundations support Minnesota Compass, including SWIF.

through the airport. Area Patriot Guards, Boy Scout Troops and others lined the walkways, saluting and shaking hands with passing veterans. Cheers rang out as the plane landed in Washington, D.C., and was met by a water cannon salute from local fire trucks, followed by patriotic music playing through the terminal and greetings from local volunteers.

A highlight at the end of the trip was Mail Call, where each veteran received letters and pictures from southwest Minnesota students.

"Everybody I talked to on that flight had a wonderful experience," Qualley said. "Even the weather cooperated! I was very impressed with the efficiency and with the help we got to make the operation run smoothly."

Visits to the WWII Memorial, Navy, Air Force and Marine memorials, National Air and Space Museum, and attending ceremonies at Arlington National Cemetery kept veterans on the go. Honor Flight's two-day itinerary would seem ambitious

to see what the experience did for veterans. They need and deserve the chance to connect, reflect and share their stories and Honor Flight provides that."

SWIF's grant to support Honor Flight Southwest Minnesota was made through the Paul and Alma Schwan Aging Trust Fund, a designated endowment fund established in 1990-1991 with a generous gift from Marvin Schwan in honor of his parents. The fund was created to help communities prepare for and respond to the opportunities and challenges of our aging rural region, including the increasingly urgent need to honor our WWII veterans.

"We're losing about 1,100 WWII veterans every day across the country and that means we're losing opportunities to do something very special for our veterans right here in southwest Minnesota, too. Not only is this a great way to honor people who have done so much, it's a great way to honor our region."

Honor Flight Southwest Minnesota is accepting additional donations to cover trip expenses, which for the two-day trip total about \$800 for each veteran. They're also







for any visitors to our nation's capital but for a group of 80and 90-year-olds, it was especially demanding and made the volunteer medical team and guardians even more important.

SWIF President/CEO Sherry Ristau accompanied as a guardian and Jim Keul of Slayton, who serves on SWIF's Board of Directors, went as part of the medical team. Volunteers helped in administering medication and oxygen, getting veterans in and out of wheel chairs and overall watching for signs that anyone may need assistance. They felt it was truly an honor to return the favor of serving those who had served our country decades before.

"This trip—these veterans—are truly amazing," Ristau said. "The experience was one of my top five, right up there with my wedding and the births of my children. It was incredible

recruiting veterans to participate in the next flight set for April 2011. Those interested in participating must complete an application. Applications are currently accepted from World War II Veterans of southwest Minnesota on a first-come, first-served basis.

Guardians are also needed to make these flights possible, ensuring that every veteran has a safe and memorable experience. Guardians are responsible for their own expenses, approximately \$800.

ENTREPRENEURSHIP INITIATIVE RECEIVES PRESTIGIOUS AWARD

SWIF recently received an Excellence in Economic Development Award from the International Economic Development Council (IEDC) for our Entrepreneurship Initiative. The awards annually recognize the world's best economic development programs and partnerships, marketing materials and the year's most influential leaders.

The award honors organizations and individuals in 28 categories for their efforts in creating positive change in urban, suburban and rural communities. SWIF's award represented the Entrepreneurship category for communities with populations of 200,000 to 500,000 and was presented to Program Specialist Jackie Turner-Lovsness at an awards ceremony Sept. 28 during the IEDC Annual Conference in Columbus, Ohio.

"We recognize the Southwest Initiative Foundation for providing successful strategies to promote new paradigms in economic development in this period of global recovery," said William Best, IEDC chair. "Our awards honor organizations and individuals for their efforts in creating positive change in communities. The Southwest Initiative Foundation is showing that they are at the forefront of the economic development profession and are using innovative and effective practices that can be replicated in other communities."


Prior to joining SWIF, Kim was an operations manager for a mental health clinic. She also worked for seven years
