YOUTH ENERGY SUMMIT (YES!)

SWIF CHALLENGES YOUTH in this partnership with the Prairie Woods Environmental Learning Center (PWELC) that provides hands-on experiential education to address energy opportunities and issues, build teams and create dynamic leaders for our future.

- 127 youth, 23 coaches and more than 70 community organizations and businesses were involved.
- YES! teams implemented energy action projects that involved and educated hundreds of community members.
- 1,000 people took part in the Earth Day event to celebrate the accomplishments of the YES! teams and learn about energy issues and opportunities.

COMMUNITY-BASED ENERGY DEVELOPMENT AND REDI



NOT ONLY IS SWIF serving as a catalyst for our region's assets, but we are also facilitating the advancement of renewable energy across Minnesota through the Rural Energy Development Initiative (REDI). REDI is intended to maximize rural economic development and stabilize rural economies in Minnesota by building renewable energy capacity, expertise and leadership. Advancing renewable energy in Minnesota builds relationships that will ultimately strengthen our region's economic and social fabric.

- Educated over 1,000 people throughout Minnesota on topics related to community-based energy and wind energy in general.
- Developed the REDI program to provide outreach, education, project development assistance and loan funding to rural Minnesotans interested in community wind.
- Created collaborative partnerships with many organizations to implement REDI.

ENTREPRENEURSHIP



THROUGH THE ENTREPRENEURSHIP Initiative, SWIF has become a leader in building on and strengthening the entrepreneurial fabric in southwest Minnesota and providing the tools entrepreneurs need to be successful, increase wealth in their business and create prosperity in their communities. Youth entrepreneurship plays a vital role in this initiative, placing importance on exposing students to opportunities and encouraging them to build their businesses within the region.

- More than 70 entrepreneurs, lenders, educators, economic developers and civic leaders attended the first Entrepreneurship Network Academy.
- More than 35 educators attended the first Youth Entrepreneurship Academy. Task groups were formed to address goals, including creating an electronic tool for resource providers and entrepreneurs, and growing youth programs throughout the region.
- Step Up Your Business, a business support network, was created and launched in three communities with 27 businesses participating.

EDUCATIONAL OPPORTUNITIES

SWIF STAFF PARTNERED with

Minnesota West Community and Technical College, Ridgewater College and the Small Business Development Center (SBDC) to increase educational opportunities and technical assistance availability to existing and aspiring entrepreneurs, including Microenterprise Loan Program clients, as well as entrepreneurial resources throughout the region.

- Monthly entrepreneurial education classes were offered in Hutchinson, Marshall, Redwood Falls, Willmar, Litchfield and Worthington.
- SWIF staff offered and taught management seminars in marketing and Quickbooks training attended by business owners and representatives.

LOANS

SWIF LOAN PROGRAMS increase the prosperity and wealth of southwest Minnesota through economic advancement by providing gap financing to new, expanding and acquired businesses. These programs also strengthen SWIF's relationships with key constituents including banks, business leaders, economic development professionals and public officials.

- Booked loans totaling \$807,600 in seven different communities.
- Created or retained 342 jobs.
- Loan customers leveraged \$3,018,800 in private funding and \$286,800 in public funding.
- Transitioned the administration of all SWIF Loan Programs, with the exception of the Microenterprise Loan Program, from Prairieland EDC to a new internal SWIF loan department.

MICROENTERPRISE LOAN PROGRAM

SWIF'S MICROENTERPRISE LOAN Program helps create self-employment opportunities for southwest Minnesota entrepreneurs by providing microloans and business technical assistance. Self-employment is vital to all communities because business owners who are active and vested in their communities become strong leaders. SWIF's Diverse Business Program assists entrepreneurs of varied cultures and backgrounds access resources and develop businesses.

- Awarded 24 new loans, including 12 to female borrowers and four to Hispanic borrowers.
- Provided business counseling services to an average of 125 entrepreneurs each quarter.
- Expanded SWIF's Diverse Business Assistance by adding a Spanish-speaking staff person to work directly with diverse businesses throughout southwest Minnesota.
- Created a Green Energy Loan Program to assist business owners with energy conservation projects.

EARLY CHILDHOOD INITIATIVE/ THRIVE INITIATIVE

THE EARLY CHILDHOOD and Minnesota Thrive Initiatives positively impact the overall school readiness of children birth to age 5. These initiatives equip communities and their leaders to build our new generation of future leaders, arguably the region's most promising asset. The 11 established ECI coalitions and one pilot Thrive Action Team:

- Engaged more than 300 regional participants in monthly local team meetings and convened about 65 activities that impacted approximately 3,300 participants.
- Created a regional network and online forum for all coordinators to develop leadership skills and provide opportunities that aid in their communities' success and connections.
- Began hosting the Promising Strategies online database for all 66 statewide ECI coalitions.
- Provided grants and helped convene activities that benefited parents, educators and childcare professionals.

CONNECTED COMMUNITIES

THIS NEW INITIATIVE focused directly on developing and challenging leaders by implementing community-developed, asset-based, collective action. SWIF tailored the Connected Communities Partnership (CCP) model and curriculum to the region and:

- Launched a pilot community in Montevideo where 18 of the original 20 Core Team members completed the training and began project implementation.
- Launched a pilot community in New London where all 21 Core Team members and six advisors were recruited.
- Completed an assessment of pilot experiences and developed a plan to incorporate learnings into future leadership development programs.

SWIF HOSTED MORE than 350 guests at the "Just Imagine" banquet and workshops at the Southwest Minnesota State University Conference Center in Marshall.

- Showcased more than 30 of the region's talented youth through an art display and musical performances.
- Honored Connie Connell of Luverne with the Southwest Initiative Foundation Award.
- Organized workshops in partnership with Schwan's University attended by more than 100 regional private, public and non-profit leaders to help build the region's capacity for social and economic success.

GRANTS

SWIF USES GRANT resources to seize opportunities that align with our goals and priority areas and serve our constituents. In Fiscal Year 2008, SWIF awarded 212 grants totaling \$1,003,402.

- Provided a \$30,000 Regional Impact Grant Award to the Southwest Minnesota Housing Partnership for an emerging markets home ownership program to foster better community integration within emerging populations and to close the homeownership gap.
- Received a \$1 million land acquisition and planning grant from the Minnesota Environment and Natural
 Resources Trust Fund for the Minnesota River Valley Green Corridor Project to help acquire land as it becomes
 available for public use within state parks, scientific and natural areas, and wildlife management areas.
- Hosted a Community Assistantship Program (CAP) Research Fellow through the University of Minnesota to lead a strategic evaluation process.
- Received a \$25,000 grant from the Atlantic Philanthropies to participate in the Community Experience
 Partnership, a project to help leverage the Paul and Alma Schwan Aging Trust Endowment Fund, a designated
 fund, and understand the assets, needs and preferences of older adults in our region.

PHILANTHROPY

SWIF IS DEDICATED to promoting philanthropy in southwest Minnesota to help retain local wealth, strengthen communities and offer donors multiple vehicles for which to contribute their charitable dollars and fulfill their philanthropic objectives.

- The Growing Home Circle Campaign welcomed 11 new members pledging an annual commitment of \$1,000 or more to the SWIF General Endowment, a permanent resource to support SWIF's work in our region. All gifts to the SWIF General Endowment, including Growing Home Circle gifts, are matched dollar-for-dollar by The McKnight Foundation. The 66 Southwest Initiative Foundation Growing Home Circle members raised a total of \$139,000 in FY08.
- SWIF's Community Foundation Program established two new partnerships—Balaton and Clarkfield—bringing the total to 19 community foundations.
- SWIF's Designated Fund Program established nine new designated fund partnerships to help donors achieve their unique philanthropic goals, bringing total partnerships to 63. The new designated fund partnerships include:

SWIF HOSTED A VISTA volunteer, who is someone who commits to serve full-time for one year at a nonprofit organization or local government agency and work to fight illiteracy, improve health services, create businesses, and strengthen community groups. In partnership with the Minnesota Association of Volunteer Administrators (MAVA), Lindsay Holtz helped further SWIF's work in multiple areas including:

- Coordinating funding for the first classroom in Lincoln County to receive Junior Achievement and planning implementation in four additional classrooms.
- Creating and compiling evaluation tools for the Nonprofit Management Institute events, including the Financial Management and Great Boards trainings.
