Types of Bequests and Sample Bequest Language

Specific Bequest: A specific bequest involves making a gift of a specific asset, such as farmland, securities, cash or other property you own. For example, you may wish to leave your farm or 100 shares of publicly-traded securities or \$10,000 in cash. All of these are considered specific bequests.

Percentage Bequest: Another kind of bequest involves leaving us a specific percentage of your overall estate. For example, you may wish to leave 10 percent of your estate to Southwest Initiative Foundation or any of our partner funds.

- **Unrestricted Bequest**

- **Restricted Bequest**

Residual Bequest: A residual bequest is made from the balance of an estate, after the will or trust has given away each of the specific bequests. In other words, a residual bequest takes care of whatever might be left over or not accounted for. A common residual bequest involves leaving a percentage of the residue of the estate. For example, you may wish to leave 50 percent of the residue of your estate to Southwest Initiative Foundation or any of our partner funds.

- **Unrestricted Bequest**

I hereby give, devise and bequeath ALL or ___ percent (___%) of the rest, residue and remainder of my estate to Southwest Initiative Foundation, a nonprofit organization located at 15 3rd Ave. NW, Hutchinson, MN 55350, Federal Tax ID #41-1555592, to be used for SWIF's general use and purpose.

- **Restricted Bequest**

I hereby give, devise and bequeath ALL or ___ percent (___%) of the rest, residue and remainder of my estate to Southwest Initiative Foundation, a nonprofit organization located at 15 3rd Ave. NW, Hutchinson, MN 55350, Federal Tax ID #41-1555592, to be added to the _____ Fund for its endowment fund.

Contingent Bequest: A contingent bequest is made to charity only if the purpose of the primary bequest cannot be met. For example, you might leave specific property, such as a farm or cabin, to a relative-but the bequest language could provide that if the relative is not alive at the time of your death, the asset will go to Southwest Initiative Foundation or any of our partner funds.

- **Unrestricted Bequest**
